Set up procedures for brand new Companies

- 1. The proposed name of the Overseas Company should Not be the same with those registered in corresponding Companies Registry.;
- 2. Customers provide information on shareholders and directors of the Company (in this F02 form and fax to us), and make payment directly to the Company or deposited in the company's bank account in Hong Kong HSBC Bank: **819-161795-001**);
- Our agents will apply for registration and prepare relevant documents::
- 4. Waiting for the company to issue a certificate of incorporation
- 5. Production of Company seal, pre-inked chop, statutory books, share certificates, and relevant documents.
- 6. Clients collect all information and documents, and proceed to open bank accounts.

Gentle REMINDER

- (1) Subsequent annual renewal fee: HK\$8,880.
- (2) In case bank a/c opening is required, please let our staff know in advance. As more documents are to be prepared, extra cost is required. Kindly let inform our staff before incorporation of company.
